BIOGRAPHICAL NOTES

Pablo Canedo has been Chief of Mission (Chargé d'Affaires) of the Embassy of the Plurinational State of Bolivia in Washington, D.C., since July 2017. He was born in Tarija and graduated from law school at the Universidad Juan Misael Saracho (UJMS) in 1999 and then pursued post graduate studies in Criminal Sciences at Universidad de Habana, Cuba, in a joint degree program with UJMS. Later he was Fulbright Scholar (2002-03) in legal studies at the University of California, Davis and concluded his Master Degree in Law (LL.M) at the University of Minnesota Law School, Minneapolis. In 2003 he worked with the UN Human Rights Commission on issues pertaining to transnational corporations and human rights. From 2004-15 he was a partner at the law firm, Canedo & Associates, focusing on commercial, corporate, penal, labor, and civil law. During 2006, he worked as a Legal Consultant in the area of Management and Procedures for the Inter-American Development Bank, on a project focused on the reforestation and recovery of the water supply of the Rincon de la Victoria and the Sama Mountain Range. In 2015, he was candidate for Governor of Tarija and in July of that year, he was appointed National Director of the Pilcomayo and Bermejo River Basins interfacing with the governments of Argentina and Paraguay on behalf of the Government of Bolivia.
